Minutes of the meeting of the IQAC held on 13th January, 2022 Thursday.

The meeting commenced with Dr. Seema Purohit, Principal, BMCC formally welcoming the members followed by a presentation by Dr. Varsha Deshpande, IQAC Coordinator. The highlights of the presentation included the reading of the minutes of the previous meetings of the IQAC, a review of the activities of 2021, progress of the special sub committees of IQAC ie a) Collaboration with professional bodies b) National and International Collaborations c) Entrepreneurship and Innovation. The report of the academic and administrative audit was placed before the meeting and the roadmap to future plans was discussed.

The following was discussed/suggested by the members:

- 1) The members discussed the parameters for outcome analysis and Prof A.B. Deshpande suggested that the local requirements to be taken into consideration for the same. The

principal and faculty members explained the salient features of the OBE platform on the ERP system of BMCC.

- 2) CA Chandrashekhar Chitale, suggested that the academic week activity shall be conducted on a regular basis in order to acquaint the students with the contemporary issues in the field of Commerce and Management.
- 3) Dr Seema Purohit briefed the members regarding the details of the D G Karve chair for research. Dr Rajeshree Gokhale highlighted the benefits of research project conducted with Prof Manjusha Wadekar and the students. This initiative was well appreciated by all the members.
- 4) Shri Milind Kamble suggested the idea of launching a BMCC Commerce Research Journal.
- 5) The members collectively discussed the prospects of a course in 'Sustainability Management'. CA Chitale and Shri Kamble gave key inputs for the same.
- 6) Dr Lanjekar highlighted the need to identify the areas for development of patents in the field of commerce. Prof A B Deshpande and Dr Chitnis gave valuable suggestions for the same.
- 7) Shri Kamble suggested the maximum use of autonomy provided to the institutions as a result of the gradual implementation of National Education Policy (NEP) by citing the example of a collaboration between AIIMS, IIT and IIM in Jammu for a course on Healthcare Management. He also suggested the setting up of a Small Business Development Centre (SBDC) in the college to increase the social impact of the college on Entrepreneurship Development in the local region.
- 8) The Meeting concluded over a formal vote of thanks by Dr Rajeshree Gokhale.
