- Scanned copy of Cast Certificate / Defence / Sports/ Specially abled/ Orphan Certificate (If applicable)
- Student should have to update Mobile Number, E-mail Id, Aadhar card number.
- Scanned copy of UID (Aadhar Card)
- Upload Documents if Applicable Cast/Category/Defence/Army/Sports/Specially Abled / Orphan Certificate.
- Students belonging to EWS category must write this category only and should note that Open category can not be changed to EWS after the declaration of Merit List.
- Please Note that the entrance exam will be conducted online in the College Computer Laboratory.
- Appearing for Entrance exam is mandatory for further admission process.

- The nature of questions of the entrance exam will be MCQ type.
- The students will be given 60 minutes for solving minimum 50 MCQs.
- Each MCQ will carry 2 marks. Thus, MCQ Test will be of 100 marks.
- Students belonging to EWS and other categories must upload the certificate at the time of filling application form.

GUIDELINES OF ADMISSION PROCESS FOR M. COM. PART I (2024-25)

- 1. Title: The degree shall be titled as Master of Commerce (M. Com.) under the Faculty of Commerce.
- **2. Duration:** The Course shall be a full-time course and the duration of the course shall be of two years.

3. Eligibility:

- (i) A candidate for being eligible for admission to this master's degree course shall have passed Bachelor Degree from Commerce stream or Bachelor in Economics or Business Administration or Accounts and Finance or Banking, Insurance or Financial Markets from the recognized University.
- (ii) Every eligible candidate must appear for the Common Entrance (MCQ) Test to be conducted online in the College Computer Laboratory. (Students will NOT be allowed to appear online from home.)
- **4. Medium of Instruction:** Medium of instruction shall be in English only.
- 5. Optional Subjects: There will be three Major paper available for the Master Degree programme.
 - (i) Advanced Accounting & Taxation
 - (ii) Advanced Costing
 - (iii) Business Administration

6. Common Entrance (MCQ) Test

- a) Admission to M.Com. Part I (2024-25) will be given on the basis of performance in the MCQ Test, Graduation Percentage Marks and other essential criteria decided by the College and as per the Govt. Rules & Regulations.
- b) Duration of the MCQ Test will be of one hour. The students must login before the given time.
- c) The questions in the Entrance Test will be totally based on the syllabi of various subjects at B. Com. Level such as Financial Accounting, Auditing, Taxation, Economics, Business Laws, Business Management, Banking & Finance, Cost Accounting, Statistics, Business Entrepreneurship, Marketing, Business Administration, Business Practices, etc.
- d) There will be 50 MCQs. Each MCQ carries 2 marks, thus the MCQ Test will be of 100 Marks.
- 7. While filling the Registration Form, student must mention his / her percentage of overall marks at the Graduation degree level. Marks only at the last year or last semester should not be submitted.
- 8. Final Merit List will be on basis of Graduation degree score & entrance score with 50% weightage equally.
- 9. Consolidated list of all the students appeared in the Entrance Exam. Will be displayed on the college website so that each student can check the correctness of the details submitted by him / her.
- 10. Final Merit List will be displayed few days after the display of Consolidated List.
- 11. Sample MCQs will be available on the College website.
