Following issues were discussed-

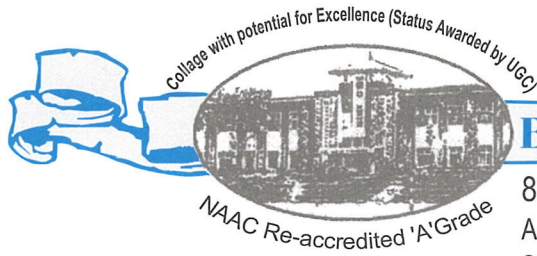
- 1) Reading & confirming the minutes of the meeting.



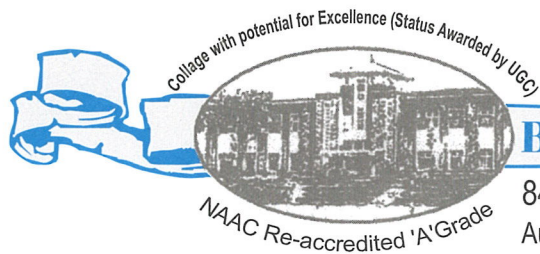
- 1) Reviewing and finalizing the draft of code of conduct for Principal, Teachers, Non-teaching staff, Students.



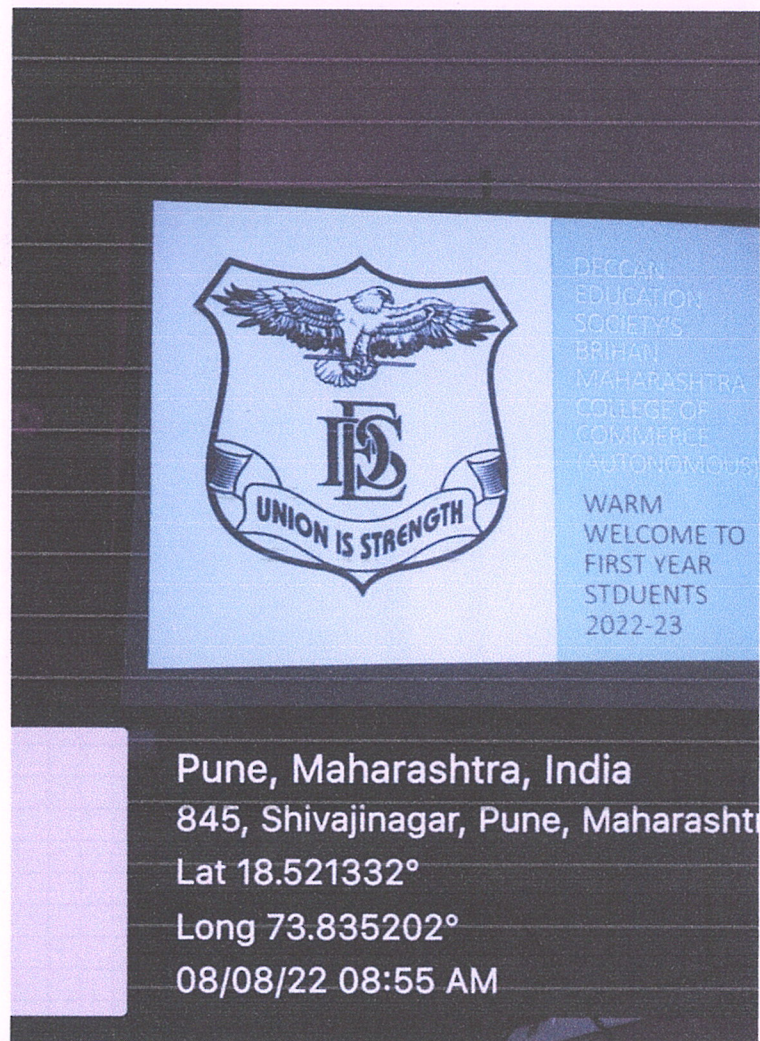
